
A MESSAGE FROM THE PRESIDENT



JCU Singapore lecturer named Halal Travel Scholar of the Year





Dr Nurhafihz Noor, Lecturer in Marketing at James Cook University in Singapore (JCU Singapore), received the "Halal Travel Scholar of the Year" title at the Halal in Travel Awards 2025 for his outstanding contributions to the Halal tourism sector.

Organised by CrescentRating, a global authority on halal-friendly travel, the <u>Halal in Travel Awards</u> celebrate travel industry players' efforts to make Halal travel a seamless experience. These awards recognise destinations, organisations, companies, and individuals who have made significant impact on the Muslim lifestyle travel.

Halal tourism is a segment of the tourism industry that caters to the unique needs and preferences of Muslim travellers. It focuses on providing services and amenities that align with Islamic principles and the faith-based requirements of Muslim tourists. This includes offering halal food, prayer facilities, gender segregation options, and environments that are free from alcohol and gambling.



Presented under the "Halal Travel Personalities of the Year" category, the award recognises <u>Dr Hafihz's</u> contributions to research and thought leadership in helping to make the tourism sector more welcoming to Muslim travellers.

"I'm glad to be part of the global conversation about the collaborative potential between industry and academia, and how such synergies need to be further tapped to create better travel experiences and more sustainable tourism ecosystems," says Dr Hafihz, whose interest in research on Muslim-friendly travel started about a decade ago.

"With increasing technological, social and environmental forces shaping travel opportunities and experiences, I hope that my research will continue to contribute to the dynamic tourism industry," he adds.

Dr Hafihz received his award during a ceremony held on Thursday, 12 June 2025. The ceremony was part of the Halal in Travel Global Summit 2025, which gathered experts, policymakers, and travel stakeholders from around the world.

"We are proud to recognise Dr Nurhafihz Noor as our Halal Travel Scholar of the Year. His work embodies the synergy between academia and industry that is

vital for our future. By translating research into actionable insights, scholars like Dr Hafihz provide the entire travel ecosystem with the critical understanding needed to innovate and create more inclusive, meaningful experiences for Muslim travellers worldwide. His contributions are invaluable to the sustainable growth of the Halal travel sector," says Mr Fazal Bahardeen, CEO of CrescentRating and HalalTrip.

"Dr Hafihz's recognition is a significant milestone that reflects both his individual contributions as well as JCU Singapore's growing role in advancing research and education on inclusive tourism," says <u>Associate Professor Wang Pengji</u>, Acting Academic Head at JCU Singapore's Business School.

"As an active researcher and educator in Marketing at JCU Singapore, Dr Hafihz has been instrumental in pioneering research that bridges academic inquiry with industry application. He has authored over 20 publications featuring Halal tourism and has been leading students to work on related projects – I have seen firsthand, his passion and contributions to the global discourse on Muslim-friendly travel," she adds.

Dr Hafihz's research interests include services marketing, technology adoption, and Halal hospitality, and he serves on several industry advisory and journal editorial boards. To date, he has published over 40 academic articles, books, book chapters, industry reports and media contributions. Beyond his research, Dr Hafihz seeks to equip students with a global, multicultural perspective on marketing and the importance of code-switching and working together with different peoples and technologies to create better value for all.

Feeding seaweed to nurture sustainable future foods: Cell-cultivated meat and seafood



Seaweed is plentiful, fast-growing, and often underutilised – but what if it could help feed the future, especially in a world where meat production and fisheries have significant environmental and health consequences for the planet? A new research project is exploring just that, by using seaweed to help grow cultivated meat and seafood.

The <u>Tropical Futures Institute (TFI)</u> at JCU Singapore and SIT are collaborating on a project to address a key challenge in cultivated meat production: developing a low-cost, high-performing sustainable alternative to traditional cell culture media. The initiative focuses on converting seaweed proteins into high-value hydrolysates, supporting circular economy principles. Protein hydrolysates are mixtures of amino acids, small proteins, and bioactive compounds that form when large proteins are broken down into smaller components.



Researchers from James Cook University (JCU) and the Singapore Institute of Technology (SIT) are exploring how seaweed could replace conventional ingredients in cell culture media, making cultivated meat and seafood more ethical, sustainable and affordable.

"Simply put, we are exploring avenues to turn seaweed into delicious cultivated meat and seafood," says TFI Research Fellow <u>Dr Thimo Ruethers</u>.

"By breaking down seaweed and its proteins into smaller components, we can create a more affordable and sustainable way to feed the animal cells used in cellular agriculture," SIT's Principal Investigator <u>Associate Professor Juan Du</u> explains.

The team uses advanced enzymatic hydrolysis technologies and protein analysis tools to identify the most effective breakdown processes for different seaweed species. The goal is to develop scalable, cost-effective and sustainable alternatives to conventional cell culture media. Not long ago, fetal bovine serum was required for cell growth.

The project, titled <u>SeaToMeat – Optimizing Seaweed Proteins to Cultivate Meat</u>, is supported by a research grant from the Good Food Institute (GFI) and a collaboration between JCU in Singapore and Australia, SIT, and industry partner Umami Bioworks. It also involves researchers from IPB (Bogor Agricultural) University in Indonesia and aims to source seaweed sustainably from farms in Indonesia and Australia.

SIT applies its food processing expertise to optimise how the seaweed-derived hydrolysates are extracted and refined. Involved JCU and SIT researchers recently showcased their collaborative impact through a study investigating future foods from mungbeans. TFI also brings its expertise in protein science, food safety, tropical aquaculture and marine science to the project, focusing on evaluating the nutritional properties of seaweed and its potential as a sustainable ingredient for cell growth media. Umami Bioworks, which specialises in innovative cellular aquaculture production, offers industry insight into the practical application of these ingredients in real-world cultivated seafood systems and previously signed a Memorandum of Understanding to explore research and development in cultivated fish safety and quality with JCU Singapore. Indonesian collaborators will provide valuable knowledge and support through regional seaweed types.

"If successful, the project could reduce the cost of cultivated meat production and lower dependence on conventional ingredients, supporting a more sustainable and ethical food system," says <u>TFI's Head of Health Sciences Professor Andreas Lopata</u>.



Transforming Lives in Southeast Asia: The Economic Benefits of Investing in Eye Health



At The Fred Hollows Foundation, we've always understood that investing in eye health transforms lives. Over the past 30 years, we've restored sight to more than 3 million people.

Now we have the data that demonstrates what we know.

The Fred Hollows Foundation has recently released a groundbreaking report in partnership with Victoria University's Institute of Strategic Economic Studies, that outlines the economic benefits of investing in eye health. The report, which used an investment case economic modeling technique, estimates the return on investment (ROI) in eye health to achieve the World Health Assembly (WHA) targets by 2030. The results show that investments in eye health are among the highest ROI of any disease intervention.

The report focuses on the two leading causes of blindness and vision impairment – cataract and refractive error – and models intervention costs and benefits across 19 countries in which The Foundation works. The benefits of restoring sight, which in this report focus solely on economic returns, include increased labour force participation and productivity, and improved education and learning.

Remarkably, cataract treatment, on average, returns USS20.50 for every dollar spent, while refractive error treatments return on average USS10.80 for myopia (nearsightedness) and USS8 for presbyopia (age-related vision loss). Together, investment in the two leading causes of blindness and vision impairment will return on average USS9.40 for each dollar spent.

This demonstrates what we all know – that investment in eye care has a great return.

Despite a dramatic economic upturn in recent years, the burden of blindness and vision impairment is still significantly high in the Southeast Asia region, accounting for 31% of the world's blind. That's why it is time to step up our investment in eye health in Southeast Asia. When we look at the findings from Southeast Asia, the estimated ROI for cataract treatment on average returns 22.4. Refractive error treatments return on average USS11.8 for myopia (nearsightedness) and USS8.4 for presbyopia (age-related vision loss). Together, investment in the two leading causes of blindness and vision impairment will return on average USS10.4 for each dollar spent in Southeast Asia.



Transforming Lives in Southeast Asia: The Economic Benefits of Investing in Eye Health



In Cambodia, where The Foundation has been actively working in since 1998, over 90% of blindness cases are preventable and primarily caused by cataract. Unfortunately, many people either lack the financial means to undergo the necessary surgery or are unaware of the available options. There is an ongoing need to address the challenges surrounding eye health in Cambodia, and increased investments in this area can provide a viable solution. Notably, cataract surgery in Cambodia demonstrates an estimated ROI of USS22.6, while the estimated ROIs for myopia treatment and presbyopia treatment are USS4.5 and USS3.0, respectively.

The findings provide a compelling case for impact and social investment networks to invest in eye health in Southeast Asia. Beyond the great economic return that investment in eye care yields, restored sight brings longer and healthier lives, reductions in extreme poverty, increased labor force participation and productivity, increased school attendance, gender equality and independence. Investing in eye health not only benefits individuals but also has a positive impact on communities and the region's economic development. 
